Tyler Manson: Resolution regarding Homesite Lease for electrical lines and fiber optic lines to my homesite lease near LeChee Red Rock.

Final disputes have to be sent to the Grazing Committee.

Have not seen any disputes. Have not been informed by any other Grazing Officials.

Make a request for mediation on this issue.

Hold off on this Resolution for Tyler's Homesite Lease.

No valid grazing disputes from Grazing.

Request for mediation that has been filed on this issue. No disputes at this present time.

The dispute is at the Land Department.

Two issues: Homesite Lease itself in regards to disputes, there are two issues at play... 1. Homesite Leases are pending. District One Grazing Committee can request for investigation. 2. No actual procedure to dispute for Homesite Leases. Once a Homesite Lease is finalized, there is no actual ratification in filing a dispute with the Land Department and Grazing Committee.

Hold off until the Homesite Lease Office for Tuba City and Window Rock. Documentation does need to come forth, not just from the District One Grazing Committee, so we can validate these complaints.

District One Grazing Committee, request for Homesite Leases.

Finalize Homesite Lease.

Tyler has a Homesite Lease that is approved.

Hold off on this Resolution due to the Homesite Lease Office in Tuba City, Arizona. Forward to District One Grazing Committee and LeChee Chapter.

Dispute is at the Land Department.

THE LAND IS LOCATED AT A TRACT OF LAND WITH GPS COORDINATES AS FOLLOWS: COMMENCING AT THE NORTHWEST CORNER, DESCRIBED AS 36 DEGREES 50' 40.20" NORTH AND 111 DEGREES AND 111 DEGREES 26' 53.83" WEST; THEN WEST APPROXIMATELY 205 LINEAR FEET TO A POINT DESCRIBED AS 36 DEGREES 50' 37.39 NORTH AND 111 DEGREES 26' 54.69" WEST; THEN WEST APPROXIMATELY 205 LINEAR FEET TO A POINT DESCRIBED AS 50' 37.83" NORTH AND 111 DEGREES 26' 57.03 WEST; AND RETURNING NORTH TO THE STARTING POINT APPROXIMATELY 260 LINEAR FEET.

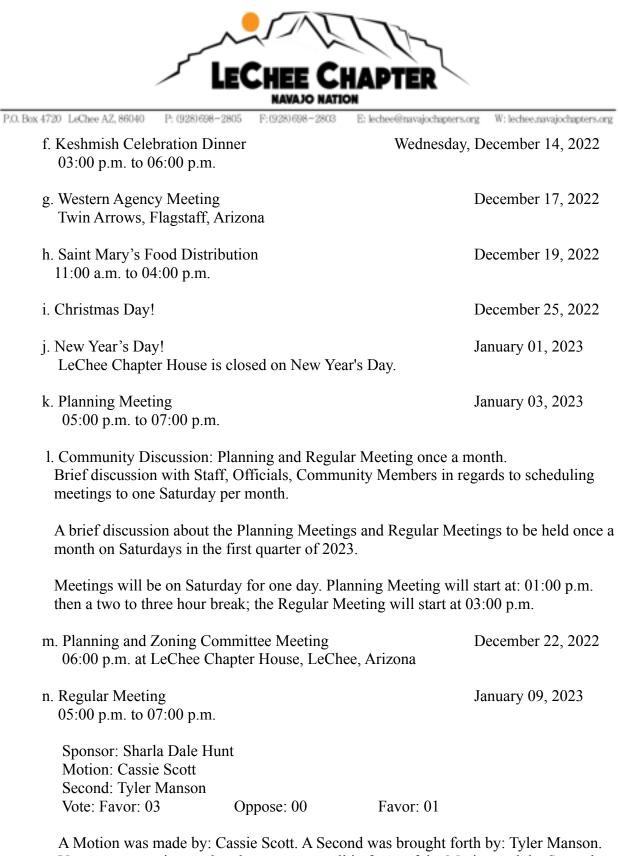
