 Main topic is Land withdrawal for private family burial plots. Any new family plots need to withdrawal and paperwork completed with the Chapters. Some people are burying everywhere and its not agreeable with the council. LeChee do not have a cemetery and needs one. All the paperwork has been sent to all the local chapters currently. Grazing person will complete coordinates to the site and approval must be given. Burial assistance and Electricity assistance is what Helena is suggesting with the Hardship money. Chinle nursing home has outstanding balance due and has asked the Navajo nation to pay the outstanding cost. Many elderly monthly moneys do not cover all the cost. Water rights were discussed in Vegas last week but currently no updates yet. Bathroom addition has been approved by the NN president. Joann Yazzie Pioche asked about her dad being denied funding from Altec, Helena explained it is a difficult interview and if help is needed then trained employees can help. Also, JoAnn Y. Pioche asked about not being paid to attend Flagstaff meeting and Tom Franklin will look into it and Renee Tsosie said a meeting can be held to discuss the issue. New senior center at Bodaway-Gap. Tonalea and Kaibeto will get new chapter house. LeChee will have the Senior center renovated.
