Update on CHID homes, by Arbin Mitchell DCD Executive Director. State of Nation address by Buu Nygren in Tuba city on Tuesday, January 14, 2025, at Grey Hills Academy. January 27, 2025 is the Winter session for the Navajo Nation council. JoAnn Y-Pioche asked who will be doing the work for bathroom addition, labor is lacking? Desiree Yellowman mentioned to hire competent labor people when working on bathroom addition. Water will build up on land for LeChee designated cemetery area due to where its located. City of Page cemetery cost is always increasing. What will be the cost of LeChee cemetery? Mr. Franklin indicated that will be up to LeChee chapter and community. Bathroom renovation supplies go bad when the chapter runs out of funds to finish the work, Mr. Franklin indicated one should pick up the cost to finish the work since the materials are waiting to be worked on. Bathroom renovation is through NECA.

- c. Tuba City Regional Hospital Board of Directors

  Lyonel is finishing up 3<sup>rd</sup> year in his term. Echo cliffs health facility in Bodaway/Gap area is slated to be completed by February 2026. The construction on the housing is south of the health facility and the land area has been determined and cleared. I.H.S. has preauthorized the construction of the housing for the medical staff. Vaccine are currently being done so get vaccinated and stay safe and sound. Percentage of people getting vaccine are low so be current with your shots. Long care facility in Tuba City by the Tuba City Hospital will be build in the future. Call for artist for the Echo Cliff Health facility, hang art, 3D, sculptures...contact Lyonel. Question about use the bathroom use facility in the LeChee clinic, only if you have been called into the clinic for an appointment or being seen you can then use the bathroom facility and if you are waiting in the clinic or going through you cannot use the bathroom facility. No word about LeChee clinic will be in operation when Echo Cliff Health is in operation, doctors are always in shortage. The pharmacy will stay in operation though.

Title three has had many changes throughout the years. Over 100 cattle have been stolen in the Gap/bodaway area. Research and investigation are being conducted of people involved from who are stealing cattle, who allowed them to be sold and who bought them. Brands were shaved off and re-branded in the mid-section. Pictures and people talking are all over social media and in the community. 10 acres has been withdrawn for the LeChee cemetery. Home site leases in LeChee are limited with 10 vacant sites available. Stanford Fowler and Tyler Manson are the only returning grazing officials. Forty eight percent of units are being utilized and 52 % are dormant un-probated.
