Mr Maloney explained financials to the community and indicated that the money from NN general fund might not support the 3<sup>rd</sup> person hire and recommended some of the funds come from PEP funds. The 3<sup>rd</sup> person hiring is not completely accepted at the NN level yet and has to be looked at. Mr Maloney introduced himself, and his position with the Tuba City Service center and their offices are technical assistance to chapters and assisting them. Also keeping chapters in compliance with their budget and spending. Irene Nez-Whitekiller suggested that the Carryover needs to be spent in helping community members, especially the needy ones. And why is there so much money with the carryover, why isn't it being spent. Alberta Lyons commented she agrees with a 3<sup>rd</sup> person hiring especially concerning giving them benefits and a stable job. Mr Maloney replied that all the money on the financial side is all NN money being given to chapters. Mr Maloney re-iterated that the 3<sup>rd</sup> person hiring isn't approved or ok yet.
