Provided verbal: updates, regarding LeChee clinic. Covid shots are still being administered here in LeChee and in Tuba City - Monday through Friday. "Protect your family". Some project funding was affected with government shut down, getting back on track. We have had a few delays with turning on water, they are working on getting these to code to get water running. Echo Cliffs will open in October 2026'. Staff housing is arriving; they are modular housing, they are very sturdy and durable. The Board has new board members, President is Dolly Lane, Vice President Ronald and secretary Carmalita Homer. There have been rumors about the closure of LeChee Clinic, these are currently rumors as there is no

decision as to what is going to happen to the clinic. A presentation was provided to members about financial gains/deficiencies and LeChee members were counted to fund Echo Cliffs. There is an upcoming resolution from a community member to have LeChee members be heard. There are unused modular clinics in Bodaway Gap that are not being used. Pharmacy is going to stay open.
