b. Tuba City Regional Hospital Board of Directors Lyonel Tso
A written report was provided by Lyonel Tso, this written report was read allowed at this regular chapter meeting.

c. LeChee Veteran Committee Michelle Alex
\$600,000 in general fund, if veterans didn't get any assistance the first time they can get assistance this time around. Of the previous allocated money \$74,969.00 was the initial budget and \$62,075.00 was paid out leaving a remaining balance of \$12,894. The remaining

balance will go to the cost of veteran coats. Michelle relays that in her resignation, she did say she would stay on to help when needed or until the position was filled.

- d. Page Attainment Group Joann Yazzie-Pioche
Joann reports that the Page reading scores are very low for specifically third graders and this information is looking to the community and LeChee chapter for recommendations to help children improve reading. Recommendations of books stations is one way, maybe a newsletter and/or even reading events, family nights with book distributions. Joann has heard of a library coming to LeChee where kids will also be able to get books to read. Joann asks for Community organizations and volunteers.

Tom Franklin answers the first question, yes you green paper CIB will be taken in exchange for the card.

Holly Phillips answers the second question, Yes the ID is supposed to be federally recognized however, some people who do not know of Native American tribes or government may turn it away out of ignorance and not malice.

Community member reports that she has run into issues where people do not recognize tribal ID's but will get a supervisor to intervene and accept it.

Comments and discussion ensue, do you have a business plan, Mr. Wilson replies yes the Department of Economic Development has it. President asks about it being in litigation, Mr. Wilson confirms it is and that this resolution is to help them continue to discuss it and to develop it. Another community member asks what caused it (Zenni Homes) to not continue, Mr. Wilson relays he does not know why it did not work. He is not asking for money upfront. The President recommends that this can be requested for deferment until more information is provided or until litigation is completed.

RESOLUTION LC02092026D THE LECHEE CHAPTER OPPOSES THE CURRENT SALE OF WHAT WAS ONCE NAVAJO NATION LAND TO BUILD AN ALLEGED 10 BILLION DOLLAR DATA CENTER ON THE OUTSKIRTS OF PAGE CITY LIMITS; THE LACK OF TRANSPARENCY FROM THE CITY OF PAGE ABOUT RISKS OF HARM, LOSS OF VITAL RESOURCES AND ENVIRONMENTAL IMPACT ON THE NAVAJO PEOPLE IS NOT BEING CONSIDERED IN THIS BUSINESS TRANSACTION; WE ARE REQUESTING THAT THE 25TH NAVAJO COUNCIL UTILIZE ALL NECESSARY RESOURCES NOT LIMITING TO LITIGATION, PROFESSIONAL INSIGHT AND ANY STUDIES NECESSARY TO PROTECT THE LECHEE COMMUNITY AND SURROUNDING NAVAJO COMMUNITIES THAT WOULD OTHERWISE BE NEGATIVELY IMPACTED BY THIS PROPOSED DATA CENTER.

Holly Phillips explains that all three officials attended a meeting in town about the DATA center. The information provided is alarming as this is being completed as a property sale and brought to the Page community for input or vote. Also, the DATA center has been declined through the city of page to utilize their electrical and water resources. This is why it is being brought to the LeChee community as the resources would then need to come from the Navajo people. Navajo People are currently working on their own water line in hopes to get water all the way to Cameron to supply potable drinking water to all the Navajos that do not have access to it now.

Sharon W. provides further information of what to look for, she does not expect Page Council to meet with LeChee, instead the investor would meet. The data center is going to be multiple buildings two stories high as big as Walmart super centers. 500 acres are being surveyed now, however, if the buyer gets the middle portion they have the opportunity to expand on either side. Page Citizens are doing what they can to counter it and also support the Navajo people getting water before the DATA center.
