Happy New Year! Delegate and LDA have been out in the field for other chapters. ARPA and Bathroom projects have been zero'd out.
 - b. Tuba City Regional Hospital Board of Directors Lyonel Tso
Verbal update: Echo Cliffs is on target to be completed in May 2026, there was a hiccup with the water however this has been remedied. Jobs will be the next target to fulfill and job openings/postings will be provided to the community. The open target date is on schedule for October 2026. The LeChee Clinic does not feel comfortable to close right away, the Pharmacy will stay open due to its load of business, to keep the clinic open numbers need to be run to see if the benefits outweigh the costs. A closure is not imminent as information still needs to be provided.
Eye Clinic: Board members were provided a presentation and a tour of the Tuba City Eye Care Services. Tuba City has an ophthalmologist to diagnose eye ailments. It is a process to get into the clinic and this is being addressed to prevent turning people away.
Arizona Tribal Nations in Phoenix and the Board members will be there the next three days.
Questions/Comments:

A community member asks where the doctors come from, and who works on Cataracts. Lyonel reports treatment occurs in Tuba City.

Renee Tsosie brings up the past lease agreement this will need to be amended to reflect the pharmacy. Lyonel comments that as of now, everything will remain the same.

February 27th will be a leadership conference in Tuba City.

- c. LeChee Veteran Committee Lyonel Tso, Michelle Alex
The Veterans Committee had agreed to occur bi-monthly and the next meeting will be held in February. Michelle will be resigning from the current Secretary position, prior to leaving she will be ordering veterans jackets. The financial assistance has been expended. Veterans and Surviving spouses include 64.
- d. Glen Canyon Outdoor Academy Niki Jaborski, School Liaison
GCOA is a free outdoor learning academy servicing grades kindergarten through 8th grade. 40% or more of outdoor learning is the focus. This year the soccer team was the runner up. This year will be the first year for the Basketball program. January 23rd is open house for GCOA. Meals are catered meals.
Open Enrollment is open now.
